## CALL FOR EXPRESSION OF INTEREST/APPLICATION FOR APPOINTMENT AS A MAGISTRATE OF THE RIVERS STATE JUDICIARY

Pursuant to the Rivers State Magistrates Courts Law, No. 2, 2004, the Rivers State Judicial Service Commission, by this notice, announces vacancies in the Office of Magistrate in the Magistracy of the Rivers State Judiciary, and hereby calls for expression of interest/application from suitable candidates for appointment as Magistrate of the Rivers State Judiciary.

#### **CADRES**

- 1) Senior Magistrate, Grade I
- 2) Senior Magistrate, Grade II
- 3) Magistrate Grade I

#### REQUIREMENTS/COMPETENCIES

To be eligible for consideration for this appointment, a candidate must satisfy the following minimum requirements:-

- i) The Candidate must be a Legal Practitioner in Nigeria and must have been so qualified, in the case of a Senior Magistrate for a period of not less than five (5) years, and in the case of a Magistrate Grade I for a period of not less than four (4) years.
- ii) The Candidate must be of good character and reputation with strong traits of diligence, hardwork, honesty, integrity, sound knowledge of law and consistent adherence to professional ethics.

- iii) The Candidate must not be above 40 years or less than 30 years, of age.
- iv) The Candidate must be computer literate.

#### **SALARY**

The office of a Magistrate is pensionable. Salaries are in accordance with Public Service Structure as applicable to the Magistracy of the Rivers State Judiciary.

- e) Proof of completion of National Youth Service/or exemption.
